SUBJECT: Establishment of Area Small Business and Disadvantaged
Business Councils

Approximately two years ago, a successful series of four small business and disadvantaged business conference workshops were held throughout the country. While it is not expected that we will have such a series of conference workshops in the immediate future, there is need for a forum or a structured format of organization which would provide for bringing together on a periodic basis small and disadvantaged business specialists and other contracting personnel.

These councils would be organized on the basis of drawing its members from several adjoining states and would meet at a frequency as they may desire to discuss and exchange views regarding small business, disadvantaged business, and labor surplus matters. These councils would elect their own officers and be made up of DoD employees and employees of other Federal agencies desiring membership. Civilian contractor personnel could also join predicated on the desires of the council membership. It is expected that you and we from the Washington level would support these councils by taking action to see that the councils are organized, and by providing support, e.g., arranging for or appearing as a conference speaker, providing latest procurement information, etc.

Accordingly, it is requested you initiate action to have councils organized as per the enclosure. Naturally, changes may be necessary regarding service responsibility, state coverage, and other matters which we are prepared to make.
