Mr. Jimmy Smith

Executive Director, SECNAV OSBP

Mr. Jimmy D. Smith assumed the responsibilities of the Director for Small Business Program in June of 2019. He serves as the chief advisor to the Secretary on all small business matters. Mr. Smith has been charged with overseeing small business acquisition policy; strengthening government and private sector partnership; and fostering opportunities to leverage small businesses as strategic advantage for the benefit of our warfighters. In March 2017, Mr. Smith served as the Deputy Assistant Secretary of the Navy for Expeditionary Programs & Logistics Management. He served as the principal advisor to the Assistant Secretary of the Navy for Research, Development and Acquisition on matters related to the Navy's Expeditionary Force, delivering upon urgent warfighter needs, and overseeing acquisition logistics policy. Mr. Smith was selected for Senior Executive Service in March 2010, after 19 years of federal service. Mr. Smith received a bachelor's of science degree in mechanical engineering, in 1990, from Tuskegee University. Graduate level studies included Environmental Engineering, Marine Engineering, and Business Management. He also possesses four executive leadership certificates from the Cornell University School of Industrial and Labor Relations and two other business-related certificates from the University of North Carolina at Chapel Hill—Kenan-Flagler Business School.

Mr. Ken Carkhuff

Learning Director, Small Business; Defense Acquisition University (DAU) (MARC Chairperson)

Mr. Carkhuff serves as the Learning Director, Small Business at DAU. Prior to joining DAU, he served as a Program Analyst in the Secretary of the Air Force Office of Small Business Programs (OSBP). Mr. Carkhuff also served as a Program Manager in the Naval Air Systems Command OSBP from 2008-2019. Prior to that, he worked for a Service-Disabled Veteran-Owned Small Business and managed several programs that supported four Acquisition Category One programs. Mr. Carkhuff is a retired naval officer and former SH-60B helicopter pilot. Mr. Carkhuff is a graduate of the United States Naval Academy (B.S., Physical Science), the Naval War College (M.A., National Security and Strategic Studies) and the Naval Postgraduate School (M.S., Contract Management). He is a member of the Defense Acquisition Corps and is Level 3 certified in Program Management and Contracting. He has served as Chairperson of the DoD MARC.

Ms. Diane Dempsey

Director, Small Business Programs, Intelligence & Security Section, BAE Systems

Ms. Dempsey has enjoyed an extensive career in the field of procurement, subcontracting and supplier diversity. Currently she is the Director, Small Business Programs for BAE Systems Intelligence & Security Sector. Ms. Dempsey has also been a small business advocate for several prime contractors in the DC Metropolitan area. She serves on multiple boards and committees as well as receiving many awards for her advocacy in the small business community.
